Hello SLL Parents,

We hope you all have a great 4th of July.

I think we all knew that it was only a matter of time before someone within our baseball family would test positive for COVID-19 as cases in South Carolina continue to rise at a fast pace.

The SLL Board wants to be as transparent as possible with informing you of when we are notified of these cases. We met earlier today to discuss the following positive cases that have some association to our organization, and how or if we should proceed with the Summer Season. The following lists the details that we know to date, and the steps we have taken to help prevent the spread at the complex.

The following two cases were reported to us on July 3rd, 2020. Both of these pertain to family members of either a coach or umpire and at this time neither person who was at the field has test results.

Last time team was at the field: 6/27/2020:

The wife of one of the coaches on the Red Sox Intermediate team tested positive for COVID-19. This person has not been to the fields since 6/24, so not there during their game on 6/27. She had symptoms on 7/1 and was tested that day, as she works in the medical field. She received her positive test results on 7/3/2020. The coach also got tested this week and he was told his test results will not be available for 5-8 days. He has not been at the field since 6/27. He and his family are now self quarantining, and they will not be back at the fields for a minimum of 14 days, after any symptoms. As of today, no other player or coach from that team has any symptoms. Both teams have been notified.

Last time at the field 7/2/2020:

The sister of the Field Umpire working the CPAA on 7/2, tested positive for COVID on 7/3. She has no symptoms, but was exposed through her church where she was helping to film last Sunday's service. No one else in the family has any symptoms including the umpire. The umpire is scheduled for testing later this week and abstaining from umpiring the next 14 days, or longer if needed. Both teams have been notified.

SLL Sanitizing

All benches and dugouts have been thoroughly sprayed with the EPA approved sanitizing spray we have been using at the complex. Same applies for the restrooms, concession stand and upstairs in the clubhouse. The solution we have been using for sanitizing is: sani-10% Disinfectant Virucide Sanitizer - Concentrated - 1 Gallon Makes Up to 180 Gallons by Chemcor Chemical.

We will continue to spray sanitizer in the restrooms hourly during game days and at the end of the day, plus the concession stand and upstairs at the end of the day.

Masks are required while using the restrooms and upstairs.

All coaches have been provided a form for tracking all coaches, players, parents and others attending games, practices or any other team event. A part of this requires parents to answer the [Self Health Evaluation](#) questions for all those in attendance that day. If any question has a YES answer, please contact your physician for clearance to play and provide a physicians note. This also applies to Umpires and SLL Volunteers.

Please help us, coaches, players and spectators by maintaining proper social distancing. Using hand sanitizer often, small spray bottles have been placed in every dugout, and umpires are sanitizing baseballs every ½ inning,
